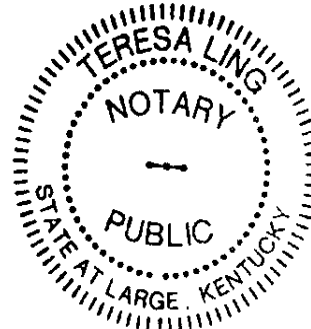

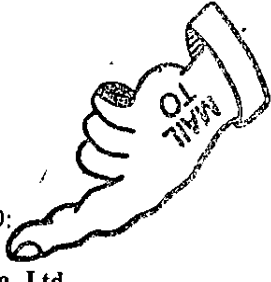

## MORTGAGE

THIS MORTGAGE ("Security Instrument") is given on August 20, 1998.

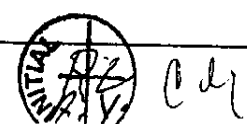
