#### LOAN MODIFICATION AGREEMENT

This is a Loan Modification Agreement ("Agreement") dated as of OCTOBER 17, 2002 by and between A.J. SMITH FEDERAL SAVINGS BANK ("Mortgagee") and FIFTH THIRD BANK AS SUCCESSOR TO OLD KENT BANK, AS TRUSTEE UNDER TRUST AGREEMENT DATED NOVEMBER 15, 2000 AND KNOWN AS TRUST NUMBER 16801.

Mortgagee has heretofore made a loan to Mortgagor in the original principal sum of ONE HUNDRED THOUSAND (\$100,000.00). Mortgagor's obligation to repay said loan is evidenced by a promissory note dated June 27, 2001 ("Note") and is secured by a mortgage ("Mortgage") dated June 27, 2001 and recorded 07/10/2001 in the Recorder's Office of Cook County Illinois as Document No. 0010606618 mortgaging, granting and conveying to Mortgagee that certain parcel of land, and the improvements thereon, located in Cook County, Illinois and legally described as:

Unit 3-South and G-1 together with the exclusive right to use storage space SS-3-South as delineated on that certain Survey of the following fand described to wit: certain lots in Roche's Edison Avenue resubdivision of Lots 1 through 4, inclusive, in Block 15 together with the West ½ of vacated Minnick lying East of said Lots 1 and 2 (intended herein to be all of Minnick Avenue) all in Minnick's Oak Lawn subdivision, being a subdivision of the Northwest ¼ and the West 20 acres of the Northeast ¼ of Section 9, Township 37 North, Range 13 East of the Third Principal Meridian, (except the North 509.94 feet of the East 696 feet Thereof) of Section 9, Township 37 North, Range 13 East of the Third Principal Meridian; which survey is attached to the Declaration of Condominium recorded 8/24/2000 as Document number 00-653006, together with its undivided percentage interest in the common elements as defined and set forth in said Declaration and Survey aforesaid, all in Cook County, Illinois.

Said Note and Mortgage are hereinafter referred to as the "Loai Documents".

Mortgagor has asked Mortgagee to lower the rate of the Note and Mortgage. Mortgagee is keeping the original maturity date and lower the interest rate of the Note and Mortgage on the terms and conditions set forth herein.

In consideration of the foregoing, and of the promises herein set fort's, the parties hereto acknowledge and agree as follows:

- 1. The principal indebtedness of \$90,000 remaining from time to time outstanding shall hereafter bear interest at the rate of 6.250% percent per annum.
- 2. Commencing NOVEMBER 01,2002 and on the first day of each successive r onth thereafter until the maturity date set forth below, Mortgagor shall installments of principal and interest in the sum of Dollars (\$561.87).
- 3. Notwithstanding any provision hereof to the contrary, the entire principal balance then oursanding and all accrued interest and other charges, shall be due and payable on AUGUSTO 1, 2031 (the "Maturity Date").
- 4. None of the rights of Mortgagee under the Loan Documents shall be prejudiced by reason of this Agreement and this Agreement shall not affect the lien and charge of the Loan Documents upon the property covered thereby.
- 5. Mortgagor hereby acknowledges and agrees that the Loan Documents remain in full force and effect, except as they have been expressly modified by the terms of this Agreement. In other respects not inconsistent with this Agreement, the terms of the Loan Documents are hereby ratified and reconfirmed.
