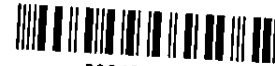


SUBCONTRACTOR'S CLAIM FOR LIEN

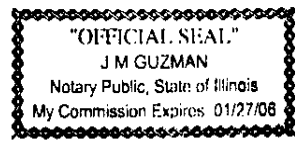
