EXHIBIT A - LONG LEGAL DESCRIPTION

THE PROPERTY AFOREMENTIONED IS HEREBY DEFINED AS FOLLOWS:

A PARCEL OF LAND BEING PART OF THE WEST HALF OF THE SOUTHWEST QUARTER OF SECTION 23, TOWNSHIP 45 NORTH, RANGE 3, EAST OF THE THIRD PRINCIPAL MERIDIAN LYING NORTHERLY OF THE HIGHWAY LEADING FROM MCCULLOM LAKE TO MCHENRY, IN THE COUNTY OF MCHENRY, DESCRIBED AS FOLLOWS: BEGINNING ON THE WEST LINE OF SAID SECTION 23 AT A POINT 1246.4 FEET NORTH FROM THE SOUTHWEST CORNER THEREOF, SAID POINT BEING IN THE CENTER OF THE AFORESAID HIGHWAY; THENCE NORTH ON SAID SECTION LINE, 709.22 FEET TO A POINT ON THE NORTH LINE OF THE SOUTH HALF OF THE NORTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 23; THENCE EAST ON THE LAST DESCRIBED LINE 111.1 FEET TO A POINT, THENCE SOUTH, PARALLEL WITH THE WEST LINE SAID SECTION, 823.8 FEET, MORE OR LESS, TO THE CENTER OF THE AFORESAID HIGHWAY; THENCE NORTHWESTERLY ALONG THE CENTER OF SAID HIGHWAY, 160.47 FEET TO THE PLACE OF BEGINNING, IN MCHENRY COUNTY, ILLINOIS.
