MORTGAGE SUBORDINATION AGREEMENT

This Moregage Subordination Agreement is given this 21st day of November, 2002 by **OAK BROOK BANK** ("Lender").

- 1. Lender holds a mortgage dated October 6, 2000, and recorded October 11, 2000, as document number 00794295 made by 60 W. Erie, L.L.C., an Illinois limited liability company to Lender covering property recated in 60 West Erie, Chicago, Illinois, as modified by that certain Modification Agreement recorded February 7, 2001 as document number 0010189528 and an Assignment of Leases and Ferts dated and recorded October 11, 2000, as document number 00794296, and Collateral Assignment of Purchase Agreements recorded October 11, 2000 as document number 00794297 (as amended from time to time, collectively the "Prior Mortgage"). The Prior Mortgage secures a Promissory Note dated as of October 6, 2000, in the original principal amount of \$19,500,000. The Prior Mortgage encumbers said property. The description of said property is set forth on the attached Schedule A.
- 2. Lender holds a mortgage on the aforementioned property dated November 21, 2002 made by West Erie, LLC, an Illinois limited liability of mpany recorded as document number 021294551, and an Assignment of Rents and Leases of even date, recorded as document number 021294552 (collectively the "Mortgage"), which Mortgage secures a Promissory Note dated as of November 21, 2002, in the original principal amount of \$25,292,646.00 (the "Loan").
- 3. The lien of the Prior Mortgage is second and subordinate to the total amount due from time to time under the terms of the Mortgage in favor of Lender regardless of when and under what conditions Lender advances proceeds of its Loan to the mortgagor the eunder. The Mortgage may be amended, modified, revised or extended, and said amendment, modification, revision or extension shall not affect the superiority and paramount lien status of the Mortgage.
- 4. This Subordination Agreement shall be binding upon Lender and all who succeed to their rights as holder of the Prior Mortgage.
