

MORTGAGE AND SECURITY AGREEMENT

THIS MORTGAGE AND SECURITY AGREEMENT (this "Mortgage") is made as of the 22nd day of October, 2002 by and between LASALLE BANK NATIONAL BANK, not personally but as Trustee Under Trust Agreement Dated May 8, 2002 and known as Trust Number 129542, and THOMAS J. COONEY & SONS PARTNERSHIP, an Illinois Partnership (collectively known as "Borrower") in the amount of TWO MILLION THREE HUNDRED THOUSAND AND NO/100 (\$2,300,000.00) DOLLARS and AMCORE BANK, N.A., ("Lender"), having its place of business at 15.33 Meacham Road, Suite 110, Schaumburg, Illinois.

FOR GOOD AND VALUABLE CONSIDERATION, including the indebtedness herein recited, the receipt of which is hereby acknowledged, Borrower hereby irrevocably warrants, grants, bargains, sells, transfers, conveys and assigns to Lender, for the benefit and security of Lender, under and subject to the terms and conditions hereinafter set forth, all of the following-described estate, property and interest of Borrower now or hereafter acquired, together with all cash and non-cash proceeds thereof, which may be referred to herein as the "Mortgaged Estate":

Lands, Rents and Derivative Interests

The real properties, located in the City of Chicago and the City of Park Ridge, County of Cook, State of Illinois; described in **Exhibit "A"** attached hereto and by this reference incorporated herein (the "Property"); all rents, issues, profits, royalties, income and other benefits derived from the Property (collectively the "rents"); all estate, right, title and interest of Borrower in and to all leases or subleases covering the Property or any portion thereof now or hereafter existing or entered into, including, without limitation, all cash or security deposits, advance rentals and deposits or payments of similar nature; all right, title and interest of Borrower in and to all options to purchase or lease the Property or any portions thereof or interest therein and any greater estate in the Property owned or hereafter acquired; all interests, estate or other claims, both in law and in equity, which Borrower now has or may hereafter acquire in the Property; all easements, rights-of-way and rights used in connection therewith or as a means of access thereto, and all tenements, hereditaments and appurtenances thereof and thereto, and all water rights and shares of stock evidencing the same; all right, title and interest of Borrower, now owned or hereafter acquired, in and to any land lying within the right-of-way of any street, open or proposed, adjoining the Froperty, and any and all sidewalks, alleys and strips and gores of land adjacent to or used in connection with the Property,

Improvements

Any and all buildings and improvements now or hereafter erected on the Property, including but not limited to, the fixtures, attachments, appliances, equipment, machinery and other articles attached to such buildings and improvements (the "Improvements");



Personal Property

All right, title and interest of Borrower in and to all tangible personal property now owned or hereafter acquired by Borrower is now or at any time hereafter located on or at the Property or used in connection therewith, including, but not limited to: all building materials stored on the Property, goods, machinery, tools, equipment (including fire sprinklers and alarm systems, air conditioning, heating and refrigerating equipment, equipment for electronic monitoring, entertainment, recreation, window or structural cleaning, maintenance, exclusion of vermin or insects, removal of dust, refuse or garbage and all other equipment of every kind), lobby and all other indoor and outdoor furniture (including tables, chairs, planters, desks, sofas, shelves, lockers and cabinets), wall beds, wall safes, furnishings, appliances (including dishwashers, garbage disposal units, refrigerators, fans, heaters, stove, water heaters and incinerators), inventory, rugs, carpets and other floor coverings, draperies and drapery rods and brackets, awnings, window shades, venetian blinds, curtains, lamps, chandeliers and other lighting fixtures and maintenance and other supplies, other than such property owned by tenants of Borrowers (the "Personal Property");

Intangibles

All of Borrower's interest in all existing and future accounts, contract rights, general intangibles, files, books of account, agreements, permits, licenses and certificates necessary or desirable in connection with the acquisition, ownership, leasing, construction, operation, servicing or management of the Mortgaged Estate (as defined herein), whether now existing or entered into or obtained after the date hereof, all existing and future names under or by which the Mortgaged Estate or any portion thereof may at any time be operated or known, all rights to carry on business under any such names or any variant thereof, and all existing and future telephone numbers and listings, advertising and marketing materials, trademarks an goodwill in any way relating to the Mortgaged Estate or any portion thereof; and

Claims and Awards

All the estate, interest, right, title, other claim or demand, including claims or demands with respect to the proceeds of insurance in effect with respect thereto, which Borrower now has or may hereafter acquire in the Mortgaged Estate, and any and all awards made for the taking by eminent domain, or by any proceeding or purchase in lieu thereof, of the whole or any part of the Mortgaged Estate, including, with our limitation, any awards resulting from a change of grade of streets and awards for severance damages, and Borrower bereby authorizes, directs and empowers Lender, at its option, on Borrower's behalf, or on behalf of the successors of assigns of Borrower, to adjust, compromise, claim, collect and receive such proceeds and to give proper receipts and equittances therefor.

TO HAVE AND TO HOLD the Mortgaged Estate hereby granted or mortgaged or intended to be granted or mortgaged, unto Lender, its successors and assigns, in fee simple forever.

PROVIDED HOWEVER, that these presents are upon the conditions that, if the indebtedness secured hereby shall be paid when due, and if the Borrower shall keep, perform and observe all and singular obligations, covenants, agreements and provisions in this Mortgage expressed to be kept, performed by and observed by or on the part of the Borrower, then this Mortgage and the estate and rights hereby granted shall cease, determine and void, but otherwise shall be and remain in full force and effect.



THIS MORTGAGE SHALL SECURE THE FOLLOWING INDEBTEDNESS AND OBLIGATIONS:

- (i) Payment of indebtedness evidenced by those certain Promissory Notes dated October 22, 2002 (the "Note") executed by Borrower and Cooney Funeral Home, Ltd., in favor of Lender in the aggregate principal amount of \$2,300,000.00 bearing interest and being payable as provided therein. Upon the occurrence of an event of default and certain other circumstances, interest is charged at a default rate (the "Default Rate"). The Note is incorporated herein by reference as if fully set forth herein:
- (ii) Payment of all indebtedness and performance of all obligations and covenants of Borrower under that certain Assignment of Rents and Leases as between Lender and Borrower dated as of the date of the Note (the "Assignment of Rents and Leases"), and each agreement of Borrower incorporated by reference therein or herein, or contained therein or herein;
- (iii) Payment of all of the principal of and interest on any future advances under Loan Documents and all sums advanced by Leader to protect the Mortgaged Estate, with interest thereon at the Late Rate and/or Default Rate provided by the Note from the date of advance by Lender to the date of payment by Borrower;
- (iv) Payment of all other inclubtedness an performance of all other obligations and covenants of Borrower contained in any Loan Document (as defined herein), together with any other instrument given to evidence or further secured hereby or thereby; and
- (v) Payment of all other sums, with interest thereon, which may hereafter be owed by Borrower or its successors or assigns pursuant to the Loan Documents to Lender or its successors or assigns.

The indebtedness and the obligations secured by this Moragage, which are describe in (i) and (v) above, may be referred to herein as the "Secured Obligations."

This Mortgage, the Note, the Loan Agreement, the Assignment of Rents and Leases, that certain Environmental Indemnity Agreement dated as of the date of the Note by Forrower to Lender (the "Environmental Agreement") and any other instrument given to evidence or further secure the payment and performance of any of the several Secured Obligations are hereafter referred to on the "Loan Documents".

All capitalized terms used but not otherwise defined herein shall have the meanings assigned to such terms in the Note.

ARTICLE I

REPRESENTATIONS, WARRANTIES, COVENANTS AND AGREEMENTS OF BORROWER

Borrower hereby represents, warrants, covenants and agrees:

SECTION 1.01. Payment of Secured Obligations. Borrower hereby grants this Mortgage to secure the payment and performance when due of the Secured Obligations. The consideration received by Borrower to execute and deliver this Mortgage and the liens and security interests created herein is sufficient and will provide a direct economic benefit to Borrower.

SECTION 1.02. <u>Title of Borrower</u>. Borrower has, subject to Permitted Encumbrances set forth in Exhibit B hereto, in its own right, good, marketable and indefeasible title in fee simple to the Mortgaged Estate, which is free from encumbrance superior to the encumbrance created by this Mortgage and has full right to make this conveyance.

SECTION 1.03. Capital Improvements. Borrower shall not make any expenditure for Improvements on the Property which, individually or in the aggregate, would exceed \$50,000.00 during any calendar year without the prior written approval of Lender except for the renovation of 3918 West Irving Park Road, Chicago, Illinois, which is defined in the Loan Agreement.

SECTION 1.84. Maintenance, Repair, Alterations. Borrower shall: (i) keep the Mortgaged Estate in good condition and repair, subject to reasonable and ordinary wear and tear; not to remove, demolish or substantially slter (except such alterations as may be required by laws, ordinances or regulations) any of the Improvements; (ii) complete promptly and in good and workmanlike manner any building or other improvement which may be constructed on the Property and promptly restore in like manner any Improvement which may be damaged or destroyed thereon, subject to the provisions of SECTION 1.07, and to pay when due all claims for labor performed and materials furnished therefor; (iii) comply with all laws, ordinances, regulations, covenants, conditions and restrictions now or hereafter affecting the Mortgaged Estate or any part thereof or requiring any alterations or improvements; not to commit or permit any was e or deterioration of the Mortgaged Estate; (iv) keep and maintain abutting grounds, sidewalks, roads, parking and landscape areas in good and neat order and repair; (v) comply with the provisions of any lease, if this Mortgage is on a leasehold; and (vi) not commit, suffer or permit any act to be done in or upon the Mortgaged Estate in violations or any law, ordinance or regulation.

SECTION 1.05. Required Insurance. Borrowers shall provide, maintain and keep at all times in force the following policies of insurance:

- (a) Insurance against loss or damage to the Improvements by fire, seepage, backup of sewers and drains and any of the risks covered by insurance of the type now known as "fire and extended coverage," in the amount not less than the original amount of the Note or the full replacement cost of the Improvements and Personal Property, whichever is greater; and with a reductible from the loss payable for any casualty in amounts acceptable to Lender. The policies of insurance carried in accordance with this subparagraph (a) shall contain the "Replacement Cost Endorsement;"
- (b) Business interruption or loss of rent insurance for and in such periods and in such amounts as are satisfactory to Lender;
- (c) Comprehensive general liability insurance (including coverage for elevators and escalators, if any, on the Mortgaged Estate and, if any construction of new Improvements occurs after execution of this Mortgage, completed operations coverage for two years after construction of the Improvements has been completed) on an "occurrence basis" against claims for "personal injury," including, without limitations, bodily injury, death or property damage occurring on, in or about the Mortgaged Estate and the adjoining streets, sidewalks and passageways, such insurance to afford immediate minimum protection to a limit satisfactory to Lender and in no event less than \$1,000,000.00 with respect to personal injury or death for any occurrence and in a general aggregate amount of \$3,000,000.00.
 - (d) Workers' compensation insurance (including employer's liability insurance, if required by

Lender) for all employees of Borrower engaged in or with respect to the Mortgaged Estate in such amount as is satisfactory to Lender, or, if such limits are established by law, in such amounts;

- (e) During the course of any construction or repair of Improvements on the Property, builder's completed value risk insurance against "all risks of physical loss," including collapse and transit coverage, during construction of such Improvements, with deductibles acceptable to Lender, in non-reporting form, at Borrower option covering the total value of work performed and equipment, supplies and materials furnished. Such policy of insurance shall contain the "permission to occupy upon completion of work or occupancy" endorsement;
- (f) If requested by Lender, boiler and machinery insurance covering pressure vessels, air tanks, boilers, machinery, pressure piping, heating, air conditioning and elevator equipment and escalator equipment, provided the Improvements contain equipment of such nature, and insurance against loss or occupancy or use rising from any such breakdown, in such amounts as are satisfactory to Lender;
- (g) Flood insurance if the property is in an area identified as a special flood hazard area pursuant to the Flood Disaster Protection Act of 1973, as amended, or other applicable law, with such insurance to be at least the amount available under the National Flood Insurance Act of 1968 and, if available under other policies issued by other sources, then in such additional amounts as Lender may reasonably require; and
- (h) Such other insurance, including, without limitation, earthquake insurance, as may from time to time be required by Lender in such amounts and against such hazards and risks as is commonly obtained by prudent owners of property similar in use to the Mortgaged Estate and located in the same area in which the Property is located.

All policies of insurance required by the terms of this Mortga 3e shall contain an endorsement or agreement by the insurer that any loss shall be payable in accordance with the terms of such policy notwithstanding any act or negligence of Borrower which might otherwise result in forfeiture of said insurance and the further agreement of the insurer waiving all rights of setoff, counterclaim or deductions against Borrower.

SECTION 1.06. Delivery of Insurance Policies; Payment of Premiums. All policies of insurance shall be issued by companies and in amounts as required by the provisions of the Loan Documents and as named otherwise satisfactory to Lender. All policies of insurance shall name Lender as a named insured, and shall have attached thereto a Lender's loss payable endorsement for the benefit of Lender, which endorsement indicates that all insurance proceeds are payable directly to Lender, and shall be otherwise in form satisfactory to Lender. Borrower shall furnish Lender with an original or certified copy of all policies of required insurance.

Thirty (30) days prior to the expiration of each such policy, Borrower shall furnish Lender with evidence satisfactory to Lender of the reissuance of a policy continuing insurance in force as required by this Mortgage. All such policies shall contain a provision that such policies will not be cancelled or materially amended in any manner, including, without limitation, amended to reduce the scope or limits of coverage, without twenty (20) days' prior written notice to Lender and shall provide that no claims shall be paid thereunder without at least ten (10) days' prior written notice to Lender. In all cases, Borrower shall immediately give notice to Lender of any notice received by Borrower of any expiration, cancellation or modification of, or material reduction of coverage under, any such policy.

In the event Borrower fails to provide, maintain, keep in force or deliver and furnish to Lender the policies of insurance required by this Mortgage or make the deposits required hereunder, Lender may procure such insurance or single-interest insurance for such risks covering Lender's interest, and Borrower will pay all premiums thereon promptly upon demand by Lender, and until such payment is made by Borrower, the amount of all such premiums, together with the interest thereon at the Late Rate and/or Default Rate provided by the Note, shall be secured by this Mortgage.

Borrower shall deposit with Lender on the first business day of each and every calendar month, until all Secured Obligations are paid in full, a non-interest-bearing amount equal to one-twelfth of the estimated aggregate annual insurance premiums on all policies of insurance required by this Mortgage. Borrower further agrees to cause all bills, statements or other documents relating to the foregoing insurance premiums to be sent or mailed directly to Lender. Upon receipt of such bills, statements or other documents, and provided Borrower has deposited sufficient funds pursuant to this SECTION 1.06, Lender shall pay such amounts as may be due thereunder out of the funds so deposited. If at any time and for any reason the funds so deposited are or will be insufficient to pay such amounts as may then or subsequently be due, Lender may notify Borrower and Borrower shall immediately deposit an amount equal to such deficiency with Lender. Notwithstanding the foregoing, nothing contained herein shall cause Lender to be deemed a trustee of such funds or to be obligated to expend any amounts in excess of the amount of funds so deposited pursuant to this SECTION 1.06, provided that Lender may, at any time thereafter, in its sole discretion, rescind such waiver by notice, whereupen borrower shall resume depositing such amounts in the manner required hereunder. If Lender waives Borrower's obligation to deposit amounts in the manner described above, Borrower shall pay all insurance premiums at least thirty (30) days prior to their due dates and shall, within ten (10) days of such payment, deliver proof thereof to Lender.

Upon occurrence of an Event of Default, Lender may, at any time at Lender's option, apply any sums or amounts received pursuant hereto, or as rents or income of the Mortgaged Estate or otherwise, upon any Secured Obligation in such manner and order as Lender may elect. The receipt, use or application of any such sums by Lender hereunder shall not be construed to affect the maturity of any Secured Obligation or any of the rights or powers of Lender under the terms of the Loan Documents or any of no obligations of Borrower or any Guarantor under the Loan Documents.

Estate or any part thereof, Borrower shall give prompt written notice thereof to Lerder and each insurer and promptly submit a claim to insurer for payment of insurance proceeds; Borrower shall provide Londer with a copy of such claim.

(a) All proceeds of insurance paid or payable under any insurance policy (the "Insurance Proceeds") with respect to the Mortgaged Estate shall be paid to Lender, each insurer is hereby authorized and directed to make payment for any such loss directly to Lender instead of payment to Borrower. Any Insurance Proceeds shall be applied first to the payment of all costs and expenses incurred by Lender in obtaining such proceeds. The balance of the proceeds, if any, may be applied at the option of Lender, (i) toward altering, restoring or rebuilding the Mortgaged Estate or such portion thereof that may have been altered, damaged or destroyed, or (ii) against sums secured hereby in such order as Lender may in its absolute discretion elect. Such damage or destruction shall not affect the lien of this Mortgage or the obligation of Borrower hereunder, and Lender is authorized at Lender's option to compromise and settle all loss claims on said policies if not adjusted promptly by Borrower.

- (b) Notwithstanding the application of Insurance Proceeds to the payment of a portion of the Secured Obligations, any unpaid portion of the Secured Obligations shall remain in full force and effect, and Borrower shall not be excused in the payment thereof. If any act or occurrence of any kind or nature on which adequate insurance was not obtained or obtainable shall result in damage to or loss or destruction of the Mortgaged Estate, Borrower shall give immediate notice thereof to Lender and, unless otherwise so instructed by Lender, shall promptly, at Borrower's sole cost and expense, whether or not the Insurance Proceeds are adequate to cover such cost and expense, restore, repair, replace and rebuild the Mortgaged Estate as nearly as possible to its value, condition and character immediately prior to such damage, loss or destruction, in accordance with plans and specifications submitted to and approved by Lender.
- Except as provided below, nothing contained in this Mortgage shall be deemed to excuse Borrower from repairing or maintaining the Mortgaged Estate as provided in SECTION 1.04 hereof. The application or release by Lender of any Insurance Proceeds shall not cure or waive any Event of Default or notice of default under this Mortgage or invalidate any act done pursuant to such notice. If Lender elects not to so apply the Insurance Proceeds to the restoration, rebuilding or repair of the Mortgaged Estate pursuant to SECTION 1.97(a) hereof, Borrower shall not be required to restore, rebuild or repair the portion of the Mortgaged Estate damaged or destroyed, and the failure to do so shall not constitute an Event of Default under this Mortgage.

SECTION 1.08. Assignment of Policies Upon Foreclosure. In the event of the foreclosure of this Mortgage, or other transfer of title to the Mortgaged Estate, or any part thereof, by nonjudicial foreclosure sale or deed in lieu of foreclosure, the purchaser of the Mortgaged Estate, or such part thereof, shall succeed to all of Borrower's rights, including any rights to unexpired in surance and unearned or returnable premiums, in and to all insurance policies required by SECTION 1.05, subject to limitations on assignment of blanket policies, and limited to such rights as relate to the Mortgaged Estate or such part thereof. If Lender acquires title to the Mortgaged Estate, or any part thereof, in any manner, it shall thereupon (as between Borrower and Lender) become the sole and absolute owner of the insurance policies, and all proceeds payable increunder with respect to the Mortgaged Estate, or such part thereof, required by SECTION 1.05, with the sole right to collect and retain all unearned or returnable premiums thereon with respect to the Mortgaged Estate, or such part thereof. If any.

SECTION 1.09. Indemnification; Subrogation; Waiver of Of 1561.

- (a) If Lender is made a party defendant to any litigation concerning this Mortgage or the Mortgaged Estate or any part thereof or interest therein, or the occupancy thereof by Borrower, then Borrower shall indemnify and hold Lender harmless from all liability by reason of such litigation, including all attorneys' fees and expenses incurred by Lender in any such litigation, whether or not any such litigation is prosecuted to judgment. Upon an Event of Default, Lender may employ an attorney or attorneys to protect its rights hereunder, and in the event of such employment following an Event of Default, Borrower shall pay all attorneys' fees and expenses incurred by Lender, whether or not an action is actually commenced against Borrower by reason of an Event of Default.
- (b) Borrower waives any and all right to claim or recover against Lender, its officers, employees, agents and representatives, for loss of damage to Borrower, the Mortgaged Estate, Borrower's property or the property of others under Borrower's control from any cause insured against of required to be insured against by the provisions of this Mortgage.
 - (c) All sums payable by Borrower hereunder shall be paid without notice, demand,

counterclaim, setoff, deduction or defense and without abatement, suspension, deferment, diminution or reduction, and the Secured Obligation of Borrower hereunder shall in no way be released, discharged or otherwise affected by reason of: (i) any damage to or restriction of or any condemnation or similar taking of the Mortgaged Estate or any part thereof; (ii) any restriction or prevention of or interference with any use of the Mortgaged Estate or any part thereof; (iii) any title defect or encumbrance or any eviction from the Property or the Improvements or any part thereof by title paramount or otherwise; (iv) any bankruptcy, insolvency, reorganization, composition, adjustment, dissolution, liquidation or other like proceeding relating to Borrower, or any action taken with respect to this Mortgage by any trustee or receiver of Borrower, or by any court, in any such proceeding; or (v) any other occurrence whatsoever, whether similar or dissimilar to the foregoing; whether or not Borrower shall have notice or knowledge of any of the foregoing. To the extent permitted by law, Borrower waives all rights now or hereafter conferred by statute or otherwise to any abatement, suspension, deferment, diminution or reduction of any Secured Obligation.

SECTION 1.10. Taxes and Impositions.

- (a) Subject to paragraphs (d) and (e) of this SECTION 1.10, Borrower agrees to pay, prior to delinquency, all real properly taxes and assessments, general and special, and all other taxes assessments of any kind or nature whatsoever, which are assessed or imposed upon the Mortgaged Estate, or become due and payable, and which create, may create or appear to create, a lien upon the Mortgaged Estate, or any part thereof, or upon any personal property, equipment or other facility used in the operation or maintenance thereof (all of which taxes, assessments and other governmental and nongovernmental charges of like nature are hereinafter referred to as "Imposition.") provided, however, that if, by law, any such Imposition is payable, or may at the option of the taxpayer (a paid, in installments, Borrower may pay the same together with any accrued interest on the unpaid balance of such Imposition in installments as the same become due and before any fine, penalty, interest or cost may be added thereto for the nonpayment of any such installment and interest.
- (b) If at any time after the date hereof there shall or assessed or imposed (i) a tax or assessment on the Mortgaged Estate in lieu of or in addition to the Impositions payable by Borrower pursuant to subparagraph (a) hereof, or (ii) a license fee, tax or assessment imposed on Lender and measured by or based in whole or in part upon the amount of the outstanding Secured Obligations, then all such taxes, assessments or fees shall be deemed to be included within the term 'Impositions" as defined in subparagraph (a) hereof, and Borrower shall pay and discharge the same as here in provided with respect to the payment of Impositions. In addition to the other remedies of Lender under Article V of this Mortgage, at the option of Lender, all Secured Obligations together with all accrued interest thereof shall become due and payable 180 days after Borrower receives written notice thereof in the event that Borrower shall not be permitted to pay such fees, taxes of assessments on behalf of Lender.
- (c) Subject to the provisions of subparagraph (d) of this SECTION 1.10, Borrower covenants to furnish Lender within 30 days after the date upon which any such Imposition is due and payable by Borrower, official receipts of the appropriate taxing authority, or other proof satisfactory to Lender, evidencing the payment thereof.
- (d) Subject to the applicable state law provisions, Borrower shall have the right before any delinquency occurs to contest or object to the amount or validity of any Imposition by appropriate legal proceedings, but this shall not be deemed or construed in any way as relieving, modifying or extending Borrower's covenant to pay any such Imposition at the time and in the manner provided in this SECTION

1.10, unless Borrower has given prior written notice to Lender of Borrower's intent to so contest or object to an Imposition, and unless, at Lender's sole option, (i) Borrower shall demonstrate to Lender's satisfaction that the legal proceeding shall conclusively operate to prevent the sale of the Mortgaged Estate, or any part thereof, to satisfy such Imposition prior to final determination of such proceedings; (ii) Borrower shall furnish a good and sufficient bond or surety as requested by and satisfactory to Lender; and (iii) Borrower shall have provided a good and sufficient undertaking as may be required or permitted by law to accomplish a stay of such proceedings.

month, until all Secured Obligations are paid in full, a non-interest-bearing amount equal to one-twelfth of the annual Impositions estimated by Lender to be next due on the Mortgaged Estate. Lender may imposed or reserve for future payment of Impositions such portion of such payments, as Lender may in its absolute discretion deem proper, applying the balance on the Secured Obligations. If Borrower fails to deposit sum officient to fully pay such Impositions at least thirty (30) days before delinquency thereof, Lender may, at Lender's election, but without any obligation so to do, advance any amounts required to makeup the deficiency, which advances, if any, shall be secured hereby and shall be repayable to Lender as herein elsewhere provided, or at the option of Lender, Lender may, without making any advance whatever, apply any sums held by it upon any Secured Obligation.

- (f) Borrower covenants and agrees not to suffer, permit or initiate the joint assessment of the real and personal property, or any other procedure whereby the lien of the real property taxes and the lien of the personal property taxes shall be assessed, levied or charged to the Mortgaged Estate as a single lien.
- (g) If requested by Lender, Borrower shall cause to be furnished to Lender, at Borrower's expense, a tax reporting service covering the Mortgaged Estate of the type and duration and with a company satisfactory to Lender.

SECTION 1.11. <u>Utilities</u>. Borrower shall pay when due all utility charges which are incurred for the benefit of the Mortgaged Estate or which may become a charge or lien against the Mortgaged Estate for gas, electricity, water or sewer services furnished to the Mortgaged Estate and all other assessments of charges of a similar nature, whether public or private, charges of a similar nature, whether public or private, affecting the Mortgaged Estate or any portion thereof, whether or not such taxes, assessments or charges are liens thereon.

SECTION 1.12. Actions Affecting Mortgaged Estate. Borrower shall appear in and contest any action or proceeding purporting to affect the title of Borrower in the Mortgaged Estate or security hereof or the

Should Borrower fail to make any payment or to do any act as and in the manner provided in this Mortgage, Lender, in its sole discretion, without obligation to do so and without notice to or demand upon Borrower and without releasing Borrower from any Secured Obligation, may make or do the same in such manner and to such extent as Lender may deem necessary to protect the security hereof. Should the Mortgaged Estate, or any part thereof or Eminent Domain. interest therein, be taken or damaged by reason of any public improvement or condemnation proceeding, or in any other manner ("Condemnation"), or should Borrower receive any notice or other information regarding such proceeding, Borrower shall give prompt written notice thereof to Lender. Lender may participate in any such Condemnation proceedings, and Borrower shall from time to time deliver to Lender all instruments requested by Lender to permit such participation. SECTION 1.17. <u>Additional Indebtedness</u>. Subject to Permitted Encumbrances, the Borrower shall not further encumber the Mortgaged Estate or any portion thereof (including, without limitation, secured transactions under the UCC) without the prior written consent of Lender.

SECTION :13. Successors and Assigns. This Mortgage applies to, inures to the benefit of and binds all parties bereto, their heirs, legatees, devisees, administrators, executors, successors and assigns. The covenants and agreements of Borrower contained herein shall apply to and be binding upon any successor owner of the Mortgaged Estate of any pert thereof.

SECTION 1.19. Inspections. Lender, or its agents, representatives or workmen, are authorized to enter at any reasonable time upon or in any part of the Mortgaged Estate for the purpose of inspecting the same and all books, records and documents relating thereto, and for the purpose of performing any of the acts it is authorized to perform under the terms of any of the Loan Documents.

SECTION 1.20. Liens. Borrower shall pay and promptly discharge, at Borrower's cost and expense, all liens, encumbrances and charges upon the Mortgaged Estate, or any part thereof or interest therein. Borrower shall have the right to contest in good faith the valid ty of any such lien, encumbrance or charge, provided Borrower shall first deposit with Lender a bond or other security satisfactory to Lender in such amounts as Lender shall require but not more than 150% of the amount of the claim plus costs (including attorneys' fees) and interest, and provided further that Borrower shall thereafter diligently proceed to cause such lien, encumbrance or charge to be removed and discharged. Borrower shall give advance notice in writing to Lender of any proposed change in Borrower's name, identity, or business form or structure and will execute and deliver to Lender, prior to or concurrently with the occurrence of any such change, all additional financing statements that Lender may require to establish and maintain the validity and priority of Lender's security interest with respect to any of the Mortgaged Estate described or referred to herein.

- (d) Borrower shall file a voluntary petition in bankruptey or shall be adjudicated a bankrupt or insolvent, or shall file any petition or answer seeking or acquiescing in any reorganization, arrangement, composition, readjustment, liquidation, dissolution or similar relief for itself under any present or future federal, state or other statute, law or regulation relating to bankruptey, insolvency or other relief for debtors; or shall seek or consent to or acquiesce in the appointment of any trustee, receiver or liquidator or Borrower or of all or any part of the Mortgaged Estate, or of any or all of the royalties, revenues, rents, issues or profits thereof, or shall make any general assignment for the benefit of creditors, or shall admit in writing its inability to pay its debts generally as they become due;

- a writ of execution or attachment or any similar process shall be issued or levied against all (f) or any part of or interest in the Mortgaged Estate, or any judgment involving monetary damages shall be entered against Borrower which shall become a lien on the Mortgaged Estate or any portion thereof or interest therein and such execution, attachment or similar process or judgment is not released, bonded, satisfied, vacated or stayed within sixty (60) days after its entry or levy;


