

## AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS, COVENANTS AND BY-LAWS, FOR THE VICTORIA CONDOMINIUM

AMENDMENT made as of the day of October, 2002, by Wrigleyville Development Corp., an Illinois corporation (the "Declarate").

- 1. <u>UNITS AND DESCRIPTIONS</u>. Units P-1, P-2, P-3, P-4, and P-5 shall consist of the space enclosed and bounded by the horizontal and vertical planes constituting the boundaries of such Units as shown on Exhibit "A" Amended attached hereto and made a part hereof. The legal description of each such Unit shall consist of the identifying number or symbol of such Unit followed by the legal description of the Property as shown on Exhibit "1-B" attached hereto and made a part hereof.
- 2. <u>FORCE AND EFFECT</u>. Except insofar as hereinabove modified and amended, the Declaration shall remain in full force and effect in accordance with its terms.
- 3. <u>DEFINED TERMS</u>. Any capitalized terms used but not defined in this Amendment shall have the meanings ascribed to such terms in the Declaration.
