- B. 
Prior Security Interests. Authority to Perform. If Mortgagor fails to perform any duty or any of the covenants contained in this Security Instrument, Lender may, without notice, perform or cause them to be performed. 
- 5. DUE ON SALE. Property. Any action or inaction occurs that adversely affects the Property or Lender's rights in the Property.
