This document is recorded of the purpose of amending the First Consolidated, Amended and Restated Declaration of Condominium (hereafter the "Declaration") for the Boardwak of Park Ridge Condominium Association, (hereafter the "Association"), which Declaration was recorded as Document Number 24558782 in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property") legally described in Exhibit "A," which is attached hereto and made a part hereof.

The amendment is effective upon recordation.

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been subjected to the covenants contained therein; and

WHEREAS, the following Amendment has been approved by all of the members of the Board, which approval is attached hereto as Exhibit B; and

WHEREAS, the following Amendment has been approved by at least 80% of the unit owners, which approvals are attached hereto; and 0021237737

WHEREAS, pursuant to Paragraph 30, a copy of said instrument has been mailed by certified mail to all mortgagees having bona fide liens of record, which mailing is certified to by a member of the Board of Directors of the Association attached hereto as Exhibit C.

NOW, THEREFORE, the First Consolidated, Amended and Restated Declaration of Condominium for the Boardwalk of Park Ridge Condominium Association is hereby amended in accordance with the text which follows (Additions in text are indicated by a double underline; deletions by strike-outs):

- 1. Paragraph 9 of the Declaration is hereby amended by adding subparagraph (n) to the section dealing with the responsibility of the Association for maintenance, repair and replacement of the Limited Common Elements as follows:
 - (n) water, sewer, electrical and other operating systems outside of the individual Townhouse Units.
- 2. Paragraph 9 of the Declaration is hereby amended by amending the second subparagraph (e) dealing with the responsibility of the Unit Owners for maintenance, repair and replacement of the Limited Common Elements, as follows:
 - (e) water, sewer, electrical and other operating systems serving the <u>Townhouse</u> Unit exclusively to the extent such systems lie within the <u>Townhouse</u> <u>Unit;</u>

2. Paragraph 23(b) of the Declaration is hereby amended 2s follows:

(b) No industry, business, trade, occupation or profession of any kind, commercial, religious, education, or otherwise, designed for profit, altruism, exploration or otherwise, shall be conducted, maintain, or permitted on any part of the property. No "For Sale" or "For Rent" signs, advertising or other displays shall be maintained or permitted on any part of the property except at such location and in such form as shall be determined by the Board. The right is reserved by the Developer or its agent, or agents, to place "For Sale" or "For Rent" signs on any unsold or unoccupied Unit, and on any part of the Common Elements, and the right is hereby given to any mortgagee, who may become the

Owner of any Unit, to place such signs on any Unit owned by such mortgagee. Until all the Units are sold, Developer shall be entitled to access, ingress and egress to the building and the property as it shall deem necessary in connection with the sale of any Unit. The Developer shall have the right to use any unsold Unit or Units as a model apartment or for sales or display purposes and to use any portion of the Common Elements which may be designated by the developer as a sales office and to maintain on the property until the sale of the last Unit, all models, sales offices and advertising signs or banners, if any, and lighting in connection therewith. Estate sales, garage sales, moving sales and other similar events may not be held anywhere on the property.

3. Paragraph 30 of the Declaration is hereby amended as follows:

- Amendments Subsequent to the Election of the First Board. Except as he ein otherwise provided, any provision of this Declaration may be amended, changed or modified by an instrument in writing setting forth such amendment, change or modification, signed and acknowledged by all of the members of the Board at least two-thirds (2/3rds) 80% of the Unit Owners and containing an affidavit by an officer of the Board certifying that a copy of the amendment, change or modification has been mailed by certified mail to all mortgagees having bona fide lions of record against any Unit, not less than ten (10) days prior to the date of such affidavit. Any amendment, change or modification shall conform to the provisions of the Illinois Condominium Property Act and shall be effective upon recordation thereof. No change, modification or amendment which affects the rights, privileges or obligation of the Developer or any mortgagee shall be effective without the prior written consent of the Developer or such mortgagee.
- 4. This Amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois.
- 5. Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.
