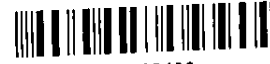


JUDICIAL SALE DEED

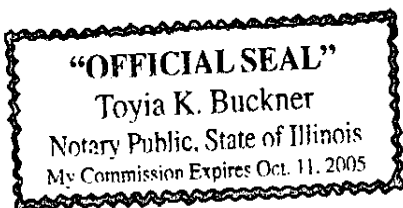

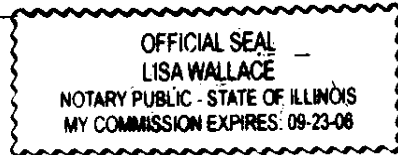

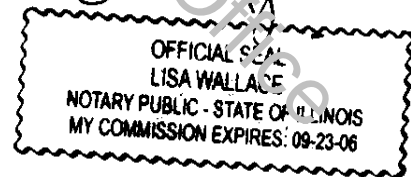
