



PARCEL 1: Unit 10108-1S together with its undivided percentage interest in the common elements in 10100-10110 South Pulaski Condominium as delineated and defined in the Declaration recorded as Document No. 0020562502, in East Half (E 1/2) of the Southeast Quarter (SE 1/4) of Section Ten (10), Township Thirty-seven North (37 N), Range Thirteen (13), East (E) of the Third (3rd) Principal Meridian, in Cook County, Illinois.

<u>PARCEL 2</u>: Exclusive use for parking in and to Parking Space No. P-10108-1S, a limit of common element, as set forth and defined in said Declaration of Condominium and Survey attached thereto, in Cook County, Illinois.

<u>PARCEL 3</u>: Exclusive use for storage purposes in and to Storage Space No. S-20, a limited common element, as set forth and defined in said Declaration of Condominium and Survey attached thereto, in Cook County, Illinois.


