AMENDMENT TO THE DECLARATION OF CONDOMINIUM OWNERSHIP FOR THE 3111 N. SEMINARY CONDOMINIUM ASSOCIATION

This Amendment to the Declaration of Condominium Ownership ("Amendment") is made as of the 28th day of October 20(2) y Cristin Obsitnik, Andrew Cohen and Elizabeth M. Cohen, Kari Lindell, Susan Porter, Beverly Melvin and John Klovanich and Tracey Klovanich (collectively, the "Unit Owners").

WHEREAS, a Declaration of Conceminium for the 3111 N. Seminary Condominium Association (hereinafter, the "Declaration"), has been recorded with the Cook County Recorder of Deeds, dated May 18, 2001 as Document No. 0010420003 which said Declaration affects property commonly known as 3111 North Seminary Avenue, Chicago, Illinois;

WHEREAS, the Declaration provided for a condominium association (hereinafter, the "Association"), but did not provide for allocation of parking spaces, whether by deeded parking spaces, or by Limited Common Elements, or by assignment from the Association; and

WHEREAS, more than two-thirds of the requisite Unit Owners of the Condominium desire to amend the Declaration so as to provide for orderly allocation of parking spaces through the designation of Limited Common Elements, as hereinafter described.

NOW THEREFORE, the undersigned, as the unanimous owners comprising the Association hereby declares as follows:

- 1. Further designation of Limited Common Elements: Notwithstanding anything in the Declaration to the contrary, the Limited Common Elements assigned and appurtenant to a Unit shall include the right to self-park one (1) passenger vehicle in the automobile parking space that is so designated for such (hereinafter, one Unit Owner's Limited Common Element for parking shall be designated as the Parking Space.
- The Association reserves to itself and to Unit Owners, their guests and their permitees the right to have reasonable pedestrian access over and onto the Parking Spaces.
