YOU ARE HEREBY NOTIFIED that the undersigned, Terra Security Systems, Inc. ("the Contractor"), 934 S. State Street, Lockport, Illinois 60441, hereby files its original contractor's claim for mechanic's lien on the real property described herein and against the interest of Andrew and Cynthia Fernandez, and BankChicago, as successor in interest to East Side Bank & Trust Company, as trustee under trust agreement #1924, dated October 8, 1977 (hereinafter collectively referred to as "the Owners"), and any parties claiming an interest in the real property by, through, or under the Owners, in connection with labor and materials furnished pursuant to the contract entered into between the Contractor and the Owners, as the owners of the real property.
