SUBORDINATION AGREEMENT

This Subordination Agreement (the "Agreement") is hereby made and entered into this 23rd day of October, 2002, by Washington Mutual Finance, LLC, a Delaware limited liability company, ("WMF"), whose post office address is 100 E. Roosevelt Road, #34, Villa Park, IL 60181.

(Joint Tenants), (ure 'Borrowers') to Washington Mutual Finance, LLC, in the original principal amount of \$26,818.00, secured by a Mortgage dated March 21, 2002, recorded on March 22, 2002, in Mortgage Book Volume Document No. 0020327593, in the records of Cook County, Illinois ("WMF Mortgage") and encumbering the property described therein ("Property") to wit:

1. The WMF Mortgage shall otherwise remain in full force and effect unless modified by WMF or by order of a court of competent jurisdiction.

- 2. WMF's agreement to subordinate, and this Agreement, are subject to the condition that the Countrywide Mortgage, and the indebtedness secured thereby:
 - a. Will not contain a balloon payment.
 - b. Will not provide for future advances.
 - c. Will not secure an open-end credit agreement.
 - d. Will provide that, in the event of default on the payment and/or default in any of the terms and conditions of the Countrywide Mortgage or the indebtedness secured thereby, and prior to the pursuit of any remedy provided thereunder, Countrywide will give written notification to WMF.
 - e. Will provide that WMF may cure any default in the Countrywide Mortgage and/or the indebtedness secured thereby, within fifteen (15) business days from the date written notification is sent.
- 3. This Agreement shall not be modified or terminated except by written instrument in recordable form.
 - 4. This Agreement shall be binding on WMF, its successors and assigns.
 - 5. This Agreement shall be governed by the laws of the state of Illinois.
