**CONTRACTOR'S NOTICE AND CLAIM FOR LIEN**

That on or about August 26, 2002 the Owner owned the land in the County of Cook, State of Illinois described on Exhibit A attached hereto and hereby made a part hereof.

That on or about August 26, 2002, the Claimant made a contract with Clark Oil and Refining Corp. as either the Lessee of the above described real estate or as agent for the Owner of the above described real estate to provide labor and material for removal of tanks, island and pipes and stone for backfill for certain improvements on said land for the sum of Twelve Thousand Three Hundred Thirty-Three and 97/100 Dollars (\$12,333.97) and on October 14, 2002, work completed was thereunder all required to be done by said contract that predates the filing of bankruptcy by Clark Oil Company.

That said owner is entitled to no credits on account thereof, leaving due, unpaid and owing to the Claimant, after allowing all credits, the balance of Twelve Thousand Three Hundred Thirty-Three and 97/100 Dollars (\$12,333.97), for which, with interest, the Claimant claims a lien on said land and improvements.

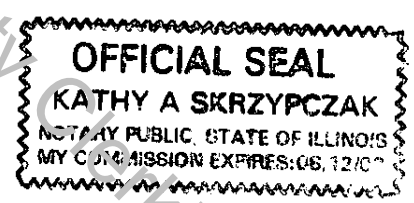
