Therefore, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Mortgagor and the Mortgagee agree as follows:

1. The Mortgage is amended to also secure the repayment of an additional extension of credit evidenced by a(n) Term Note, dated October I, 2002, payable from Dan Acquisition Corp. to the Mortgages in the original principal sum of Two Hundred Four Thousand, One Hundred Seventy Four and 86/100 Dollars (\$204,174.86), including all extensions and renewals (the "New Extension of Credit").

- 2. The Mortgage continues to secure the Original Extension of Credit and shall also secure the New Extension of Credit; therefore, the maximum principal sum of the Liabilities shall not exceed Three Hundred Thousand and 00/100 Dollars (\$300,000.00).
- 3. The Mortgagor will execute and deliver all further instruments, and shall take all other actions, as in the sole opinion of the Mortgagor are necessary or desirable to effect the intent of this Amendment.
- 4. Except as ar anded by this Amendment, all terms of the Mortgage are confirmed and ratified by the Mortgagor and the Mortgagee, as if they were fully set forth in this Amendment.
- 5. Governing Languet Venue. This Amendment is delivered in the State of Illinois and governed by Illinois law (without giving effect to its law, of coefficts); provided, however, that if the real estate that is the subject of this Amendment is located in another state, the laws of each other state shall govern the validity, enforceability, perfection, priority, construction, effect, enforcement and remedies with respect to this Amendment, but nothing herein shall be construed to provide that the laws of any state other than the State of 'linois shall apply to the obligations and indebtedness secured by this Amendment. The Mortgagor agrees that any legal action of proceeding with respect to any of its obligations under this Amendment may be brought by the Mortgages in any state of federal court located in the State of Illinois, as the Mortgage in its sole discretion may elect. By the execution and delivery of this in mendment, the Mortgagor submits to and accepts, for itself and in respect of its property, generally and unconditionally, the non-exclusive jurisdiction of those courts. The Mortgagor waives any claim that the State of Illinois is not a convenient for an or the proper venue for any such suit, action or proceeding.
- 6. WAIVER OF SPECIAL DAMAGES. THE MURTGAGOR WAIVES, TO THE MAXIMUM EXTENT NOT PROHIBITED BY LAW, ANY RIGHT THE UNDERSICNED MAY HAVE TO CLAIM OR RECOVER FROM THE MORTGAGEE IN ANY LEGAL ACTION OR PROCEEDING ANY SPECIAL, EXEMPLARY, PUNITIVE OR CONSEQUENTIAL DAMAGES.
- 7. JURY WAIVER. THE MORTGAGOR AND THE MORTGAGE! (BY ITS ACCEPTANCE HEREOF) HEREBY VOLUNTARILY, KNOWINGLY, IRREVOCABLY AND UNCONDITIONALLY WAIVE ANY RIGHT TO HAVE A JURY PARTICIPATE IN RESOLVING ANY DISPUTE (WHETHER BASED ON CONTRACT, TORT, OR OTHERWISE) BETWEEN THE MORTGAGOR AND THE MORTGAGE! ARISING OUT OF OR IN ANY WAY RELATED TO THIS DOCUMENT. THIS PROVISION IS A MATERIAL INDUCEMENT TO THE MORTGAGEE TO PROVIDE THE FINANCING DESCRIBED HEREIN.
