These agreements are on terms and conditions that are satisfactory to the notice garge insurer and the other party (or parties) to these agreements. These agreements may require the mortgage in a er to make payments using any source of funds that the mortgage insurer may have available (which may include funds obtained from Mortgage Insurance

As a result of these agreements, Lender, any purchaser of the Note, another insurer, any reinsurer, any other entity, or any affiliate of any of the foregoing, may receive (directly or indirectly) amounts that derive other entity, or any armate of any of the foregoing, may receive (differing of indirectly) amounts that derive from (or might be characterized as) a portion of Borrower's payments for Mortgage Insurance, in exchange for sharing or modifying the mortgage insurer's risk, or reducing losses. If such agreement provides that an affiliate of Lender takes a share of the insurer's risk in exchange for a strate of the premiums paid to the insurer, the arrangement is often termed "captive reinsurance." Further:

(a) Any such agreements will not affect the amounts that Borrover has agreed to pay for Mortgage Insurance or any other terms of the Lean Such agreements will not increase the amount

Mortgage Insurance, or any other terms of the Loan. Such agreements will not increase the amount

18. Transfer of the Property or a Beneficial Interest in Borrower. 
