THIS CONDOMINIUM RIDER is made this 14th day of December, 2002, and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust, or Security Deed (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure Borrower's Note to Liberty Bank for Savings. 7111 W. If the owners association or other entity which acts for the Condominium Project (the "Owners Association") holds title to property for the benefit or use of its members or shareholders, the P operty also includes Borrower's interest in the Owners Association and the uses, proceeds and benefits of Borrower's interest.
