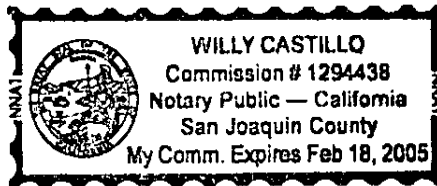

## PARCEL 1:
