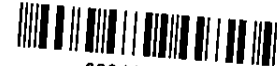



This Power of Attorney is solely in connection with the financing of the indebtedness of my principal residence located at 260 Locust, Winnetka, Illinois.

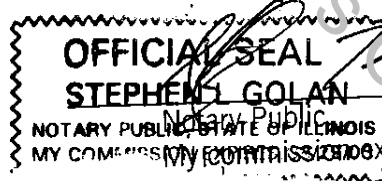


