GARAGE TRANSFER AGREEMENT

Now, therefore, and in consideration of the sun of Ten Dollars and no/100 (\$10.00) and other good and valuable consideration receipt and sufficient where it hereby is acknowledged and agreed as follows:

- Developer does hereby sell, transfer, assign, and quit claim to the Purchaser all of its rights, titles and interest and the exclusive garage right no. 148 limited foremon element, and hereafter the Purchaser shall have the right to park one passenger vehicle in the grave comprising a part of Metropolitan Place Condominium.
- 2. Purchaser does hereby sell, transfer, assign, and quit claim to the Developer all of its rights, titles and interest and the exclusive garage right no. 158 limited common elemen, and hereafter the Developer shall have the right to sell, transfer or assign this space to another party pursuant to the terms of Article 4.12 of the Declaration.
- 3. Immediately upon the recording of this instrument the aforesaid exclusive garage rights for parking space no. 148 shall henceforth be considered and treated as appurtenant to and shall run with the title to Unit 91 in the Metropolitan Place Condominium.
- This agreement shall be binding upon and shall inure to the parties hereto and their successors and assigns and to any person having at any time any interest or estate in the property described above.
