TO SECURE:

(2) The performance of the other agreements in said note, which is hereby incorporated herein and made a part hereof, and which provides, among other things, for an additional monthly payment of one-twelfth (1/12th) of the estimated annual taxes, assessments, insurance premiums and other charges upon the mortgaged premises;

(3) All disbursements by Mortgagee pursuant to this Mortgage, any future advances as hereinafter provided, and to secure the performance of Mortgagor's covenants and agreements herein contained.

#### A. THE MORTGAGOR COVENANTS:

1. That if the Mortgagor shall procure contracts of insurence upon his life and disability insurance for loss of time by accidential injury or sickness, or either such contract, making the Mortgagee assignee thereunder, the Mortgagee may pay the premiums for such insurance and add said payment to the or ocipal indebtedness secured by this mortgage, to be repaid in the manner provided for in the said note.

#### B. THE MORTGAGOR FURTHER COVENANTS:

1. That in the case of failure to perform any of the covenants herein the Mertgagee may do on the Mortgagor's behalf everything so covenanted; that the said Mortgagee may also do any act it may deem necessary to protect the lien hereof; that he will repay upon demand any moneys paid or disbursed by Mortgagee for any of the above purposes and such moneys together with interest thereon at the stated rate as provided in the Note plus one recent (1%) shall become so much additional indebtedness hereby secured and may be included in any decree foreclosing this mortgage and be paid out of the rents or proceeds of sale of said premises if not otherwise paid; that it shall not be obligately upon the Mortgagee to inquire into the validity of any lien, encumbrance or claim in advancing moneys as above authorized, but nothing herein contained shall be construed as requiring the Mortgagee to advance any moneys for any purpose nor to do any act hereunder; that the Mortgagee shall not incur any personal liability because of anything it may do or omit to do hereunder

2. That it is the intent hereof to secure payment of said note whether the entire amount shall have been advanced to the Mortgagor at the date hereof or at a later date, or having been advanced, shall have been repaid in part and further advances made at a later date. All future advances shall be wholly at Mortgagee's option, provided that any future advances, exclusive of any and all disbursements by Mortgagee as set forth herein, shall not exceed two (2) times the original principal amount of the Note.

3. If this mortgage is on a condominium unit, Mortgagor shall perform all of Mortgagor's obligations under the Declaration of Condominium or Master Deed, the by-laws and regulations of the condominium project and constituent Mortgagor shall not, without Mortgagee's prior written approval, consent to any termination of the condominium or any amendment to the declaration and by-laws governing the condominium.

4. That time is of the essence hereof, and if default be made in performance of any covenant herein contained or in making any payment under said note or obligation or any extension or renewal thereof, or if proceedings be instituted to enforce any other lien or charge upon any said property, or upon the filing of a proceeding in bankruptcy by or against the Mortgagor, or if the Mortgagor shall make an assignment for the benefit of his creditors or if his property be placed under control or in custody of any court, or if the Mortgagor abandon any of said property or in the event of the transfer of, or

agreement to transfer any right, title or interest in said property or any portion thereof, or if the Mortgagor fails to complete within a reasonable time, any building or buildings now or at any time in process of erection upon said premises, then and in any said events, the Mortgagee is hereby authorized and empowered, at its option, and without affecting the lien hereby created or the priority of said lien or any right of the Mortgage hereunder, to declare, without notice all sums secured hereby immediately due and payable, whether or not such default be remedied by the Mortgagor, and apply toward the payment of said mortgage indebtedness any indebtedness of the Mortgagor and to withdraw any credits in the name of the Mortgagor and to apply them toward the payment of said indebtedness, and the Mortgagee may also immediately proceed to foreclose this mortgage, and in any foreclosure a sale may be made of the premises en masse without offering the several parts separately.
