FIRST AMENDMENT TO THE DECLARATION OF CONDOMINIUM FOR 5840 N. ST. LOUIS CONDOMINIUMS

This document is recorded for the purpose of amending the Declaration of Condominium (hereafter referred to as "Declaration") for 5840 N. St. Louis Condominiums ("Condominium"), which Declaration was made and entered into by Aurel Rusu, Estera Rusu and Ana M. Balint ("Developer") and recorded on January 28, 2000, as Document No. 00075865 in the Office of the Recorder of Deeds of Cook County, Illinois against the Property (hereafter referred to as "Property") legally described in Exhibit 1 attached hereto.

This Amendment is adopted pursuant to the provisions of Article XII, Paragraph 10 of the Declaration which provides a method to change or modify the condominium Declaration.

RECITALS

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been submitted to the provisions of the Illinois Condominium Property Act; and

WHEREAS, Article XII, Paragraph 10 of the Declaration provides a procedure for amending the Declaration to make any changes or modifications to the Declaration, and

WHEREAS, this Amendment has been made and approved by the Developer.

NOW THEREFORE, the Declaration for 5840 N. St. Louis Condominiums is hereby amended in accordance with the text which follows (additions in text are indicated by <u>underline</u>; deletions by <u>strike-outs</u>):

Amendment 1.

The Plat of Survey is being re-recorded to correct the designation of unit numbers on said Plat. The original plat erroneously mislabeled the unit numbers and the new Plat makes corrections to said designations.

Amendment 2.

ARTICLE II DESCRIPTION OF UNITS

1. <u>Frescription</u>. All units located on the property are delineated on the survey, referred here as Exhibit "D" and made a part of the Declaration and are legally described as follows:

Unit 5836-1, 5836-2, 5836-3, 5840-1, 5840-2, 5840-3, 5836-G, 5836-1, 5836-2, 5840-G, 5840-1 and 5840-2, P-4 and P-8 in 5840 N. St. Louis Confominiums as delineated on a survey of the following described real estate:

Lots 6 and 7 in Block 2 in Pritiganwood, a Subdivision of the South ½ of the Northwest ¼ of the Southeast ¼ (except the West 33.00 feet thereof) and of that part of the South ½ of the Northeast ¼ of the Southeast ¼ lying West of the West Line of the Right of Way of the North Shore Channel Sanitary District of Chicago, in Section 2, Township 40 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois.

which survey is attached as Exhibit "D" to the Declaration of Condominium recorded in the office of the Recorder of Deeds of Cook County. Illinois.

It is understood that each unit consists of the space enclosed or bounded by the horizontal and vertical planes set forth and identified as a unit in the delineation thereof in Exhibit "D". The legal description of each unit shall consist of the identifying number or symbol of such unit followed by the legal description of the Property, as shown on Exhibit "D". Except as provided by the Act, no Unit Owner shall, by deed, plat or otherwise, subdivide or in any other manner cause the unit to be separated into any tracts or parcels different from the whole unit as shown on Exhibit "D".

2. Certain Structures Not Constituting Part of a Unit. If any chutes, flues, ducts, conduits, wires, bearing walls, bearing columns, or any other apparatus lies partially

within and partially outside of the designated boundaries of a unit, any portions thereof serving only that unit shall be deemed a part of said unit, while any portions thereof serving more than one unit or any portion of the common elements shall be deemed a part of the common elements.

Amendment 3.
