NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

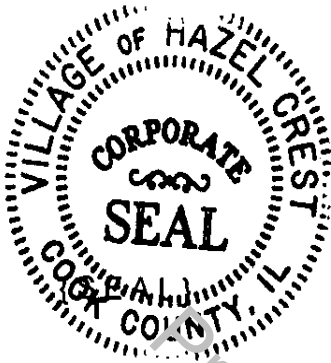

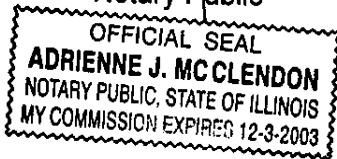
