

SUBORDINATION AGREEMENT

This Agreement is made this 25½ day of March, 2000, by and between ALAN J. LAATZ and ALANE L. LAATZ, husband and wife ("Laatz"). RICHARD C. ZEMAN ("Zeman") and BEN FRANKLIN BANK OF ILLINOIS ("Bank").

WITNESSETH:

WHEREAS, Laatz & Zeman have entered into an Agreement dated March 31, 1994, and recorded in Cock County, Illinois, as Document No. 94295184 which granted a Life Estate to Zeman, among other things, in the premises commonly known as 621 South Madison, LaGrange, IL 60525, and legally described on Exhibit "A" attached hereto and made a part hereof ("Premises");

WHEREAS, this Life Fstate was secured by a mortgage to Zeman in the amount of \$144,000.00 recorded in Cook County, Illinois, as Document No. 96939321, hereinafter referred to as "Zeman Mortgage";

WHEREAS, the bank wishes to loan additional funds to Laatz to be secured by a mortgage ('Bank Mortgage") in the event that Zeman super limites the Zeman Mortgage to the Bank Mortgage;

WHEREAS, the parties have reached an agreement regarding this subordination and wish to commit this Agreement to writing;

NOW, THEREFORE, in consideration of the aforesaid premises and for other good and valuable considerations, the receipt and sufficiency of which are hereby mutually acknowledged, the parties do hereby agree as follows:

- 1. The preambles set forth above are hereby incorporated into and made a part of this Subordination Agreement.
- 2. Zeman hereby agrees to subordinate the Zeman Mortgage to the Bank Mortgage recorded in Cook County, Illinois, as Document No. <u>00260697</u> and Zeman agree. That in all ways the Bank Mortgage shall be treated as if it was recorded prior to the Zeman Mortgage.


