THIS RELEASE AND TERMINATION OF EASEMENT AND PARTY WALL AGREEMENTS AND RIGHTS (this "Release and Termination") is granted and made this /2 \_, 2000, by American Stores Properties, Inc., a Delaware corporation (the day of Amil "Owner").

WHEREAS, Owner owns all of the Property legally described in the attached Exhibit A (the "Property");

WHEREAS, prior owners of the Property entered into the following agreement for the purpose of creating a certain easement on the Property (the "Easement"):

Agreement between 1250 South Wabash Building Corporation and Twentieth Century-Fox Film Corporation, dated January 21, 1939, and recorded February 24, 1939 as Document No. 12275177, affecting Parcel 4 of the Property, as described in Exhibit A of this Release and Termination.

WHEREAS, prior owners of the Property entered into the following agreements (the "Party Wall Agreements") for the purpose of creating certain party wall rights on the Property (the "Party Wall Rights"):

- 1. Agreement dated April 1, 1863 and recorded April 3, 1863 as Document No. 64812 made by Matthew Laflin with William C. Mallory, affecting Parcel 2 of the Property, as described in Exhibit A of this Release and Termination.
- 2. Agreement made by Horace F. Waite with Charles H. Fargo dated December 31, 1889 and recorded March 20, 1890 as Document No. 1237298, and extended by document recorded as No. 1256354, affecting Parcel 2 of the Property, as described in Exhibit A of this Release and Termination.
- Agreement made by the Northern Trust Company, as trustee with Film 3. Exchange Building Corporation, recorded April 30, 1930 as Document No.

Waitx, deceased, with Film Exchange Building Corporation, a corporation of Illinois, affecting Parcel 4 of the Property, as described in Exhibit A of this Release and Termination.
- Agreement made by Josephine Dexter in her own right and as trustee with Florence C. Hall, dated April 14, 1904 and recorded May 13, 1904 as Document No. 3537685, affecting Parcel 5 of the Property, as described in Exhibit A of this Release and Termination.
- 6. Agreement recorded May 13, 1904 as Document No. 3537686 affecting Parcel 5 of the Property, as described in Exhibit A of this Release and Termination.

WHEREAS, Grantor has not transferred or assigned any of its rights with respect to the Property, the Easement, the Party Wall Agreements or the Party Wall Rights;

WHEREAS, the purposes of the Easeman, the Party Wall Agreements and the Party Wall Rights are no longer useful, practical or applicable to the current and intended improvements on, and uses of, the Property; and

WHEREAS, Owner has acquired the interests of each and all of the parties to the Easement and the Party Wall Agreements, and as such successor in interest to said parties, Owner desires to terminate the Easement, the Party Wall Agreements and all of the Party Wall Rights with respect to the Property and with respect to the Owner.

NOW THEREFORE, the Owner hereby forever releases, terminates and extinguishes forever the Easement, the Party Wall Agreements and the Party Wall rights so that the Easement, the Party Wall Agreements and the Party Wall Rights shall be of no further force or effect with respect to the Property or the Owner, its successors and its assigns.
