THIS INDENTURE WITNESSETH, That the Grantor, Denise Y. 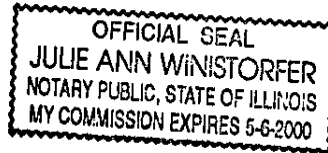

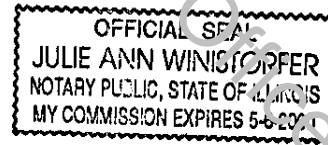
