THIS MORTGAGE ("Security Instrument") is given on April 7, 2000. The mortgagor is David B. Kim and Gina Y. Kim, husband and wife ("Borrower"). #### **CONDOMINIUM RIDER**

E. Lender's Prior Consent. Borrower shall not, except after notice to Lender and with Lender's prior written consent, either partition or subdivide the Property or consent to:
