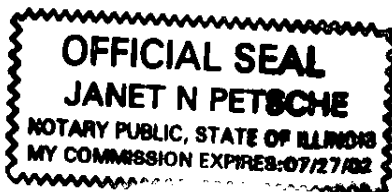

ALL THAT PART OF THE EAST 1/2 OF THE SOUTHEAST 1/4 SECTION 30-36-13 EAST OF THE THIRD PRINCIPAL MERIDIAN (EX.
