7. LENDER'S RIGHT TO PROTECT ITS RIGHTS IN THE PROPERTY

14. NOTICES REQUIRED UNDER THIS SECURITY INSTRUMENT

A notice will be given to me at an alternative address if I give Lender a notice of my alternative address. I may designate only one mailing address at a time for notification purposes.
