6. To do any and all other acts which may be necessary or required to close the above referenced loan.

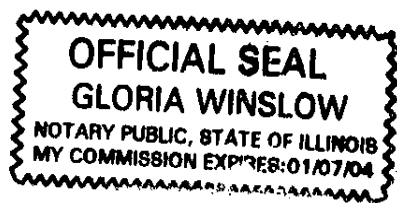
