Borrower covenants that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.

- 1. Payment of Principal and Interest. Borrower shall promptly pay when due the principal of and interest on the indebtedness evidenced by the Note and late charges as provided in the Note and the principal of and interest on any further advances secured by this Mortgage.
- 2. Home Equity Loan. This Mortgage secures a Home Equity variable interest promissory note of even date. Such Note has a ten (10) year term. Borrower will promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges give under the note.
- 3. Taxes; Insurance, Corress; Liens. Borrower shall pay all taxes, hazard insurance, assessments and other charges, fines and impositions attributable to the reporty. Borrower shall promptly furnish to Lender receipts evidencing such payments. Borrower shall promptly discharge any lien which has priority over this Mortgage; provided, that Borrower shall not be required to discharge any such lien so long as Borrower shall agree in writing to the payment of the obligation secured by such lien or in a manner acceptable to the Lender or shall in good faith contest such lien by or defend enforcement of such lien and legal proceedings which operate to prevent the enforcement of the lien of forfeiture of the Property or any part thereof.
- 4. Hazard Insurance. Borrower shall reep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "ev tended coverage" and any other hazards for which Lender requires insurance. This insurance shall be maintained in the amounts and for the periods that Lender requires. If Corrower abandons the Property, or does not answer within 30 days, a notice from Lender that the insurance carrier has offered to source a claim, then Lender may collect the insurance proceeds. Lender may use the proceeds to repair or restore the Property or to pay su ns secured by this Mortgage, whether or not then due. The 30 day period will begin when notice is given.

Unless Lender and Borrower otherwise agree in writing, any application of proceeds to principa' sha'l not extend or postpone the due date of the monthly payments referred to in paragraph 1 herein or change the amount of the payments. - Condemnation. The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conveyance in lieu of condemnation, are hereby assigned and shall be paid to Lender.

In the event of a total taking of the Property, the proceeds shall be applied to the sums secured by this Mortgage, with the excess, if any, paid to Borrov cr. In the event of a partial taking of the Property, unless Borrower and Lender otherwise agree in writing, there shall be applied to the surus secured by this Mortgage such proportion of the proceeds as is equal to that proportion which the amount of the sums secured by this Mortgage immediately prior to that date of taking bears to the fair market value of the Property immediately prior to the date of taking, with the balance of the proceeds paid to Borrower.

If the Property is abandoned by Porrower, or if, after notice by Lender to Borrower that the condemnor offer to make an award to settle a claim for damages, Borrower fails to respond to Lender within 30 days after the date such notice is mailed, Lender is authorized to collect and apply the proceeds, at Lender's options, either to restoration or repair of the Property or to the sums secured by this Mortgage.

Unless Lender and Borrower otherwise agree in writing, any such application of proceeds to principal shall not extend or postpone the due date of the monthly installments referred to in paragraph 3 hereof or change the amount of such installment.

- Borrower Not Released. Extension of the time for payment or modification of amortization of the sums secured by this Mortgage granted by Lender to any successor in interest of Corrower shall not operate to release, in any manner, the liability of the original Borrower's successors in interest. Len ler shall not be required to commence proceedings against such successor or refuse to extend time for payment or otherwise modify amo tization of the sums secured by mortgage by reason of any demand made by the original Borrower and Borrower's successors in interest
- 10. Forbearance by Lender Not a Waiver. Any forbearance by Lender in exercising any right or remedy hereunder, or otherwise afforded by applicable law, shall not be a waiver of or preclude the exercise of any such right or remedy. The procurement of insurance or the payment of taxes or other liens or charges by Lender shall not be a waiver of Lender's right to accelerate the maturity of the Note secured by this mortgage.
- 11. Remedies Cumulative. All remedies provided in the Mortgage are dis inct and cumulative to any other right or remedy under this Mortgage afforded by law or equity and may be exercised concurrently, independently or successively. 12. Agreement:

- 14. Governing Law; Severability. This Mortgage shall be governed by the law of the jurisdiction in which the Property is located. In the event that any provision or clause of this Mortgage or the Note and Agreement conflicts with applicable law, such conflict shall not affect other provisions of this Mortgage or the Note and Agreement which can be given effect without the conflicting provision and to this end the provisions of the Mortgage and Note and Agreement are declared to be severable.
- 15. Legislation Affecting Lender's Rights. - 18. Acceleration; Remedies. Prior to electing to accelerate the indebtedness, Lender shall give notice to Borrower of any such breach, of any covenant or agreement in this Mortgage (but not prior to acceleration under paragraphs 14 and 15 herein unless applicable law provides otherwise). The notice shall specify: (a) the default; (b) the action required to cure the default; (c) a date, not less than 30 days from the date the notice is given to Borrower, by which the default must be cured and (d) the failure to cure the default on or before the date specified in the notice may result in acceleration of the sums secured by this Mortgage, foreclosure by judicial proceeding and sale of the Property. The notice shall further inform Borrower of the right to reinstate after acceleration and the right to assert in the foreclosure proceeding the non-existence of a default or any other defense of Borrower to acceleration and foreclosure. If the de au't is not cured on or before the date specified in the notice, Lender at its option may require immediate payment in full of all sums secured by this Mortgage without further demand and may foreclose this Mortgage by judicial proceeding. Lender shall be entitled to collect all expenses included in pursuing the remedies provided in this paragraph 18, including but not limited to, reasonable attorne, 's lees and costs of title evidence.
- 19. Lender in Possession Upon acceleration under paragraph 18 or abandonment of the Property and at any time prior to the expiration of any period of redemptior, following judicial sale, Lender (in person, by agent, or by judicially appointed receiver) shall be entitled to enter upon, take possession of and manage the Property and to collect the rents of the Property including those past due. - 20. Release. Upon payment of all sums sec irel by this Mortgage, Lender shall release this Mortgage without charge to Borrower. Borrower shall pay any recordation costs.
  - 21. Waiver of Homestead. Borrower waives all right of homestead exemption in the Property.
- 22. Prior Mortgages. Borrower covenants and agrees to comply with all the terms and conditions and covenants of any Mortgage, trust deed, or Security Instrument affecting the Property which has or may have priority over this Mortgage, including specifically, but not limited to, timely making the payments of principal and interest due thereunder. Failure of Borrower to make such payments or keep such items, conditions and covenants as provided for in such prior mortgages, trust deeds or security agreements shall constitute a default under this mortgage and Lender may invoke the remody specified in paragraph 18 herein.

- (b) If Borrower is in default under the Agreement of this Mortgage, Lender may require Force wer to pay immediately the principal balance outstanding, any and all FINANCE CHARGES. Borrower may owe or that amount, together with all other fees, costs or premiums charged to Borrower's account. The principal balance outstanding under the Agreement after default shall continue to accrue FINANCE CHARGE until paid at the rate provided of in the Agreement as if no default had occurred.
- 24. Expense of Litigation. In any suit to foreclose the lien of this Mortgage or enforce any other remedy of the Lender under this Mortgage or the Note or the Credit Documents there shall be allowed and included, as additional indebtedness in the judgment or decree, all expenditures and expenses which may be paid or incurred by or on behalf of Borrower for attorney's fees, appraiser's fees, outlays for documentary expert evidence, stenographers' charges, publication costs, survey costs.
