5. Property Insurance. This insurance shall be maintained in the amounts (including deductible levels) and for the periods that Lender requires. The 30-day period will begin when the notice is given. If such agreement provides that an affiliate of Lender takes a share of the insurer's risk in exchange for a share of the premiums paid to the insurer, the arrangement is often termed "captive reinsurance." 
