As of August 9, 1999, Berglund entered into a written contract with Owner under which Berglund agreed to perform general contracting services in the construction of a church and multi-purpose building for the Cost of Work to a Guaranteed Maximum Price of Three Million Five Hundred Twenty Seven Thousand Nine Hundred Forty Two (\$3,527,942) subject to additions and deductions for changed work or differing site conditions.

- 3. At the special instance and request of Owner, Berglund furnished extra and additional materials and extra and additional labor for the improvement of the Property under the Prime Contract to the extent and value of One Hundred Forty-Seven Thousand Nine Hundred Sixty-Eight Dollars (\$147,968).
- 4. Berglund also furnished extra and additional materials and extra additional labor which Owner and Berglund agreed would be administered and paid outside the Contract in the amount of \$256,160 (the "Separate Contract Work"). The Unpaid portion of the Separate Contract work is not the subject of this Claim for Lien.
- 5. The Contract was entered into by Owner and the work was performed by Berglund with the knowledge and consent of Owner.
  - 6. Reglund completed Berglund's Work under the Contract on July 1, 2001.
- 7. As of the date hereof, after allowing all credits, there is due, unpaid and owing to Berglund, the principal amount of One Hundred Fifty Nine Thousand Nine Hundred Sixty Seven Dollars and 65/100 (\$159,967.65) (the "Entire Contract Amount Due"). Berglund claims a lien against the Real Estate for the lienable principal amount of One Hundred Forty-Five Thousand Three Hundred Forty-Four Dollars and 65/100 (\$145,344.65) plus interest.
- 8. Berglund hereby revokes any waiver of lien given in advance of payment for which payment was not made.
- 9. Berglund reserves all Berglund's rights and remedies to collect the Entire Contract Amount Due plus interest and costs. Berglund also reserves all Berglund's rights and remedies to collect the unpaid portion of the Separate Contract Work.
