That on July 25, 2001, the Claimant made a contract with Robert Pape & Eileen Pape, of Burr Ridge, Illinois, to perform and complete remodeling and improvements to the building already erected on said land and in said improvement for the sum of SEVEN HUNDRED NINETY NINE THOUSAND ONE HUNDRED TWENTY EIGHT (\$799,128.00) DOLLARS plus extras for said labor and materials and that on September 17, 2002 the Claimant completed thereunder all required by said contract to be done.

That at the special instance and request of said owner the claimant was to furnish work out and extra and additional labor and incurred additional costs and services on said premises of the value of TWENTY FIVE THOUSAND FIVE HUNDRED SEVEN AND 79/00 DOLLARS (\$25,507.79), and completed same on September 17, 2002.

That said owner is entitled to credits on account thereof leaving due, unpaid and owing to the claimant, after allowing all credits, the balance of FIFTY NINE THOUSAND NINE HUNDRED FORTY NINE AND 33/00 (\$59,949.33) DOLLARS, for which, with interest, the claimant claims a lien on said land and improvements.

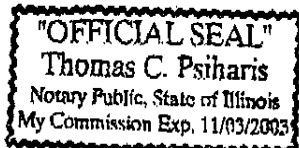
