#### THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 2

1. Mortgagors shall (1) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or he destroyed; (2) keep said premises in good condition and tepair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordinated to the lien thereof; (3) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to the Mortgagee; (4) complete within a reasonable time any building or buildings now or at any time in process of exection upon said promises; (5) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (6) make no material alterations in said premises except as required by law or municipal ordinance.

In case of default therein, Mortgagee may, but need not, make only payment or perform any act hereinbefore required of Mortgagors in any form and manner deemed expedient, and may, but need no, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or secrit any tax lies or other prior lies or title or claim thereof, or redeem from any tax sale or forfeiture affecting said premises or contest any tax or successment. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewish, including attorney's fees, and any other moneys advanced by Mortgagee to protect the mortgaged premises and the lien hereof, that to so much additional indebtedness secured hereby and shall become immediately due and payable without notice and with interest the lay at the highest rate now permitted by Illinois law. - 11.
