

HOME EQUITY LINE OF CREDIT LOAN MODIFICATION AGREEMENT

This Loan Modification Agreement ("Agreement") is made this 3rd day of December, 2002, by and between Francisco Barraza ("Borrower") married to Lorena Barraza, Juan Barraza ("Borrower") married to Carmen Barraza, and Raul Barraza, an unmarried person ("Borrower") and Corus Bank, N.A. ("Lender") and amends and supplements (1) the Home Equity Line of Credit Mortgage to secure debt (the "Mortgage"), dated November 6, 1995 and recorded in Cook County, as Document Number 96-000248 and (2) the corresponding Home Equity Line of Credit Agreement and Disclosure Statement (the Note"), bearing the same date as and secured by the Security Instrument, which covers the real and personal property described in the Mortgage and defined therein as the "Property," the real property being described as follows:

AGREEMENTS

- A. The Borrower's Final Payment Due Date will be extended until November 6. 2007. If Borrower owes any amount on the Note on the extended Final Payment Due Date, then Borrower will pay those amounts to Lender on that Date.
- B. The Borrower's Minimum Payments will change and the Periodic Statements will include such changes. The Minimum Payment will equal the accrued interest or finance charges plus a principal amount of \$37.26, plus any amount past due and all other charges.

The Borrower will comply with all covenants, agreements, and requirements of the Note and the Mortgage, including without limitation, Borrower's covenants and agreements to make all payments of taxes, insurance premiums, assessments, escrow items, impounds, and all other payments that Borrower is obligated to make under the Mortgage. Nothing in this Agreement shall be understood or construed to be a discharge, satisfaction, novation, or release in whole or in part of the Note and Mortgage.

Except as otherwise specifically provided in this Agreement, the Note and Mortgage will remain unchanged and Borrower and Lender will be bound by, and comply with, all of the terms, conditions, powers and covenants and provisions thereof, and each shall be binding and will remain in full force and effect and are otherwise unchanged except as specifically amended by this Agreement.
