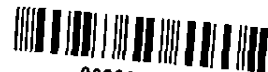


RELEASE OF MORTGAGE

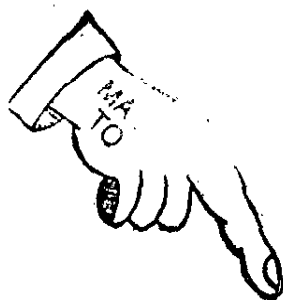

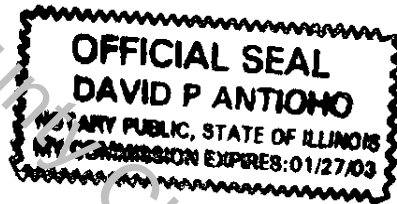
