THIS CAUSE coming to be heard pursuant to Plaintiff's Motion to reinstate this cause, vacate the dismissal order of August 13, 2002, and enter judgment against Defendant(s) pursuant to the terms of the Agreed Order previously entered in this cause, due notice having been given and the Court being advised in the premises, and the Court finding that the Defendant(s) is/are in breach of said Agreed Order:

IT IS HEREBY ORDERED:

1. That this cause is hereby reinstated, and the clerk's fee is waived;
2. That the prior Order of Dismissal is vacated, including the installment payment portion of said Order;
3. Judgment is hereby entered in favor of the Plaintiff, Citicorp Vendor Finance, Inc., a corporation, and against the Defendant, Simply Business Desktop Publishing, Inc., an Illinois corporation, on Count I of Plaintiff's Complaint, and against the Defendant, Arthur Johnson, on Count II of Plaintiff's Complaint, both in the amount of \$66,993.68, plus costs (\$272.60 to date).
4. Counts III, IV and V of Plaintiff's Complaint are dismissed, without prejudice.
5. There is no just reason to delay either enforcement or appeal, or both, of this judgment.
