RECITALS

Assignor is the Declarant under that certain Declaration for Concord City Centre, Including Matters Relating to the Concord City Centre Condominium in Cook County, Illinois as Document Number 0010527300, as amended from time to time ("Condominium Declaration"). The Plat, which is attached as Exhibit C to the Condominium Declaration, delineates various Parking spaces thereon. Parking space P-215 (the "Assigned Space") is currently assigned to Dwelling Units owned by Declarant.
