AGREEMENT

WHEREAS, in connection with the Owner's construction of a single family residence on the Property, the Owner intends to construct an outdoor deck that may in part extend over a portion of the easement area; and

WHEREAS; the parties hereto wish to clarify their relative rights and obligations with respect to the construction of said deck and the existing easement.

The Owner acknowledges and agrees that if at any time in the future the Village requires that portion of the deck which extends into or over the easement area to be removed so that the Village may exercise any of its rights set forth in the previously executed and recorded Easement Agreement, that the Owner or its successors or assigns shall bear full responsibility, including any and all costs, for removal of that portion of the weck which extends into or over said easement area; and
- The parties nereto acknowledge and agree that this Agreement shall run 3. with the land.
