# Exhibit A **Legal Description**

#### Parcel 1:

All of Lots 2, 5, 8 and 11 in Assessors Division of Lots 1, 2 and 3 in Block 1 of Clarke's Addition to Chicago, in the Southwest Fractional Quarter of Fractional Section 22, Township 39 North, Range 14, East of the Third Principal Meridian, (except from the above described tract that part thereof taken for Public Alley), in Cook County, Illinois.

### Parcel 2:

That part of the lands of Illinois Central Railroad Company, comprised of a part each of Lots 6 through 15 in Drexel's Subdivision of Block 30 in the Assessor's Division of the Northwest Fractional Quarter of Section 22, Township 39 North Range 14, East of the Third Principal Meridian, and a part of each of Lots 1 through 5 in Mortimer and Tappen's Subdivision of Lots 1 to 5 in Drexel's Subdivision aforesaid, which part of said lands is bounded and described as follows:
