Unless Lender and Borrower otherwise agree in writing, insurance proceeds shall be applied to restoration or repair of the Property damaged, provided such restoration or repair is economically feasible or if the security of this Mortgage is not thereby impaired. If such restoration or repair is not economically feasible or if the security of this Mortgage would be impaired, the insurance proceeds shall be applied to the sums secured by this Mortgage, with the excess, if any, paid to Borrower. 13. Notice. 14. Uniform Mortgage; Governing Laws; Severability.

This form of mortgage combines uniform covenants for national use and non-uniform covenants with limited variability by jurisdiction to constitute a uniform security instrument covering real property. This Mortgage shall be governed by the law of the state in which the property is located, in the event that any provision or clause of this Mortgage or the Note creates conflicts with applicable law, such conflict shall not affect other provisions of this Mortgage or the Note which can be given effect without the conflicting provision, and to the end of this Note and the Mortgage at severable.

15. Borrower's Copy. Borrower shall be furnished a conforming copy of the Note and of this Mortgage at the time of execution or after recordation hereof.

16. Transfer of the Property: Assumption. If all or any part of the Property or an interest therein is sold or transferred by Borrower without Lender's prior written consent, excluding (a) the creation of a lien or encumbrance subordinated to this Mortgage, (b) the creation of a purchase money security interest for household appliances, (c) a transfer by devise or descent or by operation of law upon the death of a joint tenant or (d) the grant of any leasehold interest by devise to the sale or transfer, Lender and the person to whom the Property is to be sold or shall have accelerated if, prior to the sale or transfer, Lender and the person to whom the Property is to be sold or shall have sums secured by this Mortgage to be immediately due and payable. The notice shall further inform Borrower of any notice of acceleration and sale of the property, including the non-existence of the note specified in the notice, Lender's right to assert in the notice may result in acceleration of the sum secured by this Mortgage, and payables without further demand and may foreclose this Mortgage by judicial procedure.
