ORDER FOR STIPULATED FINAL JUDGMENT

THIS CAUSE coming to be heard on the Court's status for entry of final judgment, the Court being fully advised in the premises, the Court finds as follows:

- 1. On April 16, 2002, Plaintiff filed a Complaint for Condemnation (the 'Complaint") relating to certain property to be acquired in fee simple and legally described on Exhibit A thereto and identified as Parcel ODE0145 (the "Property").
- 2. Plaintiff represents that all defendants named in said Complaint have been served with process as required by law and this Court has jurisdiction over the subject matter of said Complaint and over all parties thereto.
- 3. On July 2, 2002, Plaintiff was given leave to file instanter its Motion for Immediate

Vesting of Title with respect to the Property.

- 4. On September 9, 2002, due notice of Plaintiff's Motion for Immediate Vesting of Title having been given, this court entered a Stipulated Order Fixing Preliminary Just Compensation (the "Stipulated Order") in the amount of \$2,200.00 for the taking of fee simple title to Parcel ODE0145, all as described in the Complaint.
- 5. Plaintiff, on or about October 16, 2002, deposited with the Office of the County Treasurer, Cook County, Illinois said stipulated preliminary just compensation. On October 23, 2002, this Court ordered that Plaintiff be vested with fee simple title to Parcel ODE0145 and the Court authorized Plaintiff to take immediate possession of the same.
- 6. Plaintiff and Defendants have agreed, as evidenced by the parties entering into a Stipulation For Final Judgment filed with this Court, that the amount of total, final just compensation (including all interests, costs and damage to the remainder, if any) to be paid by Plaintiff for the taking of fee simple title to Parcel ODE 0145 is to be and shall be \$2,200.00, all of which said total final just compensation has previously been deposited with the Office of the County Treasurer, Cook County.
- 7. Plaintiff and Defendants have waived its demand for trial by jury.
- 8. The Court, having heard and considered the evidence and the representations of Counsel.:

IT IS HEREBY ORDERED that:

1. Final judgment is entered herein determining the amount of \$2,200.00 to be total full and final just compensation, including any and all claims for interest or damages due Defendants for the taking of fee simple title to and upon Parcel ODE0145 as described in the Complaint and attached hereto as Exhibit "A" all of which said total final just compensation has previously been deposited with the Treasurer of
