5. Property insurance. Bottower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage," and any other hazards including, but not limited to, earthquakes and floods, for which Lender requires insurance. This insurance shall be maintained in the amounts

Lender may require Borrower to pay a one-time charge for a real estate tax recollection and/or reporting service used by Lender in connection with this Loan.

The insurance carrier providing the insurance shall be chosen by Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. Lender may require Borrower to pay, in connection with this Loan, either: (a) a one-time charge for flood zone determination, certification and tracking services; or (b) a one-time charge for flood zone determination and certification services and subsequent charges each time remappings or similar changes occur which reasonably might affect such determination or certification. 8. **Borrower's Loan Application.** Borrower shall be in default if, during the Loan application or statement to Lender (or failed to provide Lender with material information with Borrower's knowledge or consent gave materially false, misleading, or inaccurate application process, Borrower or entities acting at the direction of Borrower or with Borrower's knowledge or consent gave materially false, misleading, or inaccurate application process to Lender (or failed to provide Lender with material information

9. Protection of Lender's Interest in the Property and Rights Under this Security Instrument. 11. Assignment of Miscellaneous Proceeds; Forfeiture. All Miscellaneous Proceeds are hereby assigned to and shall be paid to Lender.

(b) Any such agreements will not affect the rights Borrower has - if any - with respect to the Mortgage Insurance under the Homeowners Protection Act of 1998 or any other law. These rights may include the right to receive certain disclosures, to request and obtain cancellation of the Mortgage Insurance, to have the Mortgage Insurance premiums that were unearned at the time of such cancellation or termination.

(a) Any such agreements will not affect the amounts that Borrower has agreed to pay for Mortgage Insurance, or any other terms of the Loan. Such agreements will not increase the amount Borrower will owe for Mortgage Insurance, and they will not entitle Borrower to any refund.
