Nellie Williams further under cands that should defendant fail to appear or otherwise violate any condition of the above-described Order of Release, the United States will seek an Order from the Court authorizing the United States to file and record the above-described Quit Claim deed and to take whatever other steps may be necessary to perfect its interest in the above-described property;
- Nellie Williams further agrees that she will maintain the property in good repair, (6) pay all taxes and obligations thereon when one and will take no action which will encumber the property or diminish her interest herein, including any effort to sell or otherwise convey the property without leave of this Court; and
- Nellie Williams further understands that if she has knowingly made or submitted or **(7)** caused to be made or submitted any false, fraudulent or misleading statement or documents in connection with this agreement or in connection with bail being set for defendant, then they are subject to felony prosecution which could result in the imposition of severe penalties, including a

substantial period of incarceration.
