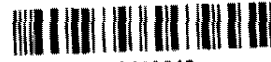


# UNOFFICIAL COPY

3. Notice was published in the Chicago Sun-Times in Chicago, Illinois, from MAY 28, 2002 through MAY 30, 2002.



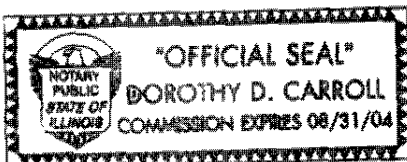
