



SUBORDINATION AGREEMENT Subordination of Mortgage

This Agreement made and entered into this <u>16th</u> day of December 2002, by and between Leyoun Credit Union and Wells Fargo Home Mortgage Inc.

WITNESSETH:

Whereas, Leyden Credit Union holds a Mortgage dated April 19, 2001 and filed April 25, 2001 as Document No. 0010336638 of the records of the County of Cook, State of Illinois, from Leyden Credit Union to Ronald W. Hawks and Marilyn Hawks to secure the sum of \$99,000.00.

Whereas, Wells Fargo Home Mortgage Inc. has entered into a Mortgage with Ronald W. Hawks and Marilyn Hawks, dated <u>(ec. 18</u> 2002, in the amount of three hundred thirty thousand, eight hundred (\$350,300.00), which will be recorded in Cook County, State of Illinois.

Whereas, Wells Fargo Home Mortgage Inc. requires that its Mortgage be a first real estate Mortgage on the real estate described as: 4781 Woodclift Lane, Palatine, IL 60067.

Whereas, Leyden Credit Union has determined that their interest would ocadequately and properly secured by a lien subordinate to the lien of the Wells Fargo Home Mortgage Inc.

Now, therefore, in consideration of the foregoing and of the receipt of other goods and valuable considerations, it is agreed as follows:

- 1. Leyden Credit Union agrees that their lien herein described shall be and is hereby subordinated to the lien of the Mortgage to Wells Fargo Home Mortgage Inc., herein before described.
- 2. Except as herein provided, nothing in this Agreement is intended to modify any of the terms or conditions of either of the Mortgages.
