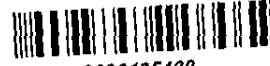

PARCEL I: The West 20.50 feet as measured on the South line thereof of that part lying East of a line drawn parallel with the East line from a point on said South line 219.83 feet West of the Southeast corner thereof and lying South of the South line of the most Northerly 10.00 feet as measured at right angles to the North line of the following described tract: That part of Lots 2, 3, 4 and Outlet "A" in Richman Manor, First Addition, Unit No. 1, being a subdivision of part of the East half of the Southeast quarter of Section 27 and part of the West half of the West half of the Southeast quarter of Section 26, Township 42 North, Range 11, East of the Third Principal Meridian, described as follows: Beginning at a point in the East line of Lot 3, which point is 29.00 feet South of the Northeast corner of Lot 3; thence West parallel with the North line of said Lot 3, a distance of 100.00 feet; thence North parallel with the East line of Lot 3, a distance of 21.00 feet; thence West parallel with the North line of Lot 3, a distance of 24.00 feet; thence North parallel with the East line of Lot 2 and 3, a distance of 30.00 feet; thence West parallel with the North line of Lot 3, and said line extended, a distance of 152.53 feet to the West line of Outlet "A"; thence South along the West line of Outlet "A", a distance of 116.00 feet, to a line 26.00 feet South of and parallel with the North line of Lot 4, extended West; thence East along said line 26.00 feet South of and parallel with the North line of said Lot 4, and said line extended, a distance of 276.01 feet to the East line of Lot 4; thence North along the East line of Lots 3 and 4, a distance of 65.00 feet, to the point of beginning, in Cook County, Illinois.
