

On g₁ before December 5, 2001, the OWNER of LAND made a contract with VUK whereby

VUK was to provide, or knowingly permitted VUK to provide labor, material, tools and equipment

for construction for said project and on or about December 5, 2001, VUK and MEMBER entered

into an oral subcontract whereby MEMBER was to provide underground plumbing, rough plumbing

and trim work for said project; thereafter, on or before September 6, 2002, OWNER terminated

VUK's contract, and OWNER entere i into an oral contract with MEMBER whereby MEMBER

would complete said work directly for OWNER and OWNER agreed to pay MEMBER for said

work as VUK was originally supposed to. MENDER thereafter completed all of its obligations

pursuant to said subcontract on or about October 21, 2002, except for that work precluded by

OWNER's failure to cooperate with MEMBER.

To date, despite due demand for payment, Claimant remains unpaid for said work; and there

is no reasonable basis for the failure to pay MEMBER.

Therefore, after all due credits, the amount left due, unpaid and owing to MEMBER is

\$10,766.54, for which amount, plus interest and collection costs, including reasonable attorneys' fees,

MEMBER claims a lien on the LAND and improvements thereon, and on any monie. Que or to

become due to VUK or any other party from OWNER for said project.
